SCHEDULE 1

1. The making and maintenance of dose records for all or any of the purposes of regulations 12, 21, 22 and 23 of the Ionising Radiations Regulations 1999 from information supplied by the Approved Dosimetry Service(s) for dose assessment.
2. The co-ordination of dose assessments for each individual for whom dose records are maintained in accordance with Criteria 6, 7, 8 of HSE's Requirements for the Approval of Dosimetry Services under the Ionising Radiations Regulations 1999, Part 3, Co-ordination and Record Keeping.
3. The making of permitted alterations to the dose records in accordance with Criterion 12 [(a), (b), (c), (d), (e), (f)] of HSE's Requirements for the Approval of Dosimetry Services under the Ionising Radiations Regulations 1999, Part 3, Co-ordination and Record Keeping.
4. The keeping of dose records in accordance with Criterion 13 of HSE's Requirements for the Approval of Dosimetry Services under the Ionising Radiations Regulations 1999, Part 3, Co-ordination and Record Keeping.
5. The provision of copies, suitable summaries and extracts of dose information to employers as required in accordance with Criterion 15 and 16 of HSE's Requirements for the Approval of Dosimetry Services under the Ionising Radiations Regulations 1999, Part 3, Co-ordination and Record Keeping.
6. The provision of summaries and information to CIDI in accordance with Criterion 17 and 18 of HSE's Requirements for the Approval of Dosimetry Services under the Ionising Radiations Regulations 1999, Part 3, Co-ordination and Record Keeping.

SCHEDULE 2

1. The functions and assessments referred to in Schedule 1 to this Certificate shall be carried out in the manner described in the Statement of Service, Co-ordination of dose information and record-keeping, 8th May 2008 supplied by Landauer Europe Limited, with their letter dated 28th April 2008.
2. In operating this service regard shall be had to the contents of Part 3 of Requirements for the Approval of Dosimetry Services issued by the Health and Safety Executive pursuant to the Ionising Radiations Regulations 1999.
3. The Health and Safety Executive will formally reassess the approval of the dosimetry service at intervals of seven years from **1st April 2001**. The service shall pay the fee for formal reassessment of approval of dosimetry services as laid down in the Health and Safety (Fees) Regulations current at that time.
4. In this schedule a reference to a Statement of Service statement shall include any amendments or revisions as may be agreed in writing by the Health and Safety Executive.
